REMINDER ON SUMMER WATER USE

With the summer months nearing and the potential of drier weather, watering of lawns and gardens become more of a priority for residents. Residents should remember that your sewer charge is based on your water usage. To avoid having



to pay higher sewer costs for summer watering usage, residents should inquire with City Staff on purchasing a lawn meter. Residents save money with a lawn meter, because water that runs through the lawn meter is not charged the sewer rate. For residents that already have a lawn meter, please double check that it is working properly when you begin using it for the season.

COMPOST SITE OPEN

The compost site is now open 7 days a week during daylight hours for residents in City limits. It is located on the Southeast corner of town, close to the waste water treatment facility, on Freedom Drive. Allowable compost: Lawn clippings, leaves (no plastic bags), garden compost. Small brush area—No stumps or logs. Chipping is available on location for large amounts of brush for a cost. Contact the office for more information.

ALLEY GARBAGE COLLECTION



The City of Arlington has notified the refuse companies, that do garbage collection in town, that the alleys are now dry enough to resume alley pickup - effective immediately.

HAVE SUMMER PROJECTS?

Here are ten things that will help you get your fencing or accessory structure project off to a good start:

1. You will need a building and/or land use permit from the City Office before starting your project. Processing time is normally one to two weeks, so please schedule accordingly.
2. Fences must have finished sides facing outward, this means you get to look at the posts when you are inside the fence.
3. Fences must have posts buried at least 30" deep and encased in cement
4. Fences can be located in side or rear yards, but fencing is not allowed in front yards.
5. Fences can be no more than six feet in height and must be of conventional fencing material.

No agricultural fencing is allowed.

6. You are responsible for finding and marking your own property lines. You may checkout a metal detector from the City Shop or contact a surveyor to locate your property pins.

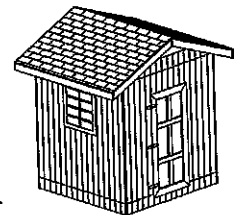
7. You are responsible for keeping accessory structures out of the easements.

8. Sheds and detached garages need to 'blend in' with your house in terms of size, shape and color.

9. Canvas covered sheds, car ports, and 'hoop shed' designs are not allowed.

10. Sheds and detached garages are subject to setback, height, and size standards.

CONCERT TO BE HELD MAY 15TH

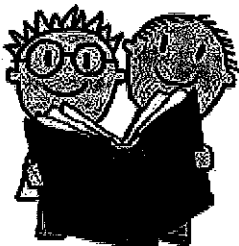

REMINDER WHEN MOWING GRASS

Residents should remember that the discharging of lawn clippings onto city streets is not allowed. Clippings that are discharged onto city streets eventually wash into the storm sewers and cause them to clog. Along with being an inconvenience to residents, clogged sewers are costly and time consuming for the City to clean and unclog. The City is asking all residents to take their grass clippings to the compost site. The compost site is open 7 days a week during daylight hours for residents in city limits.



SCHEDULED INTERRUPTION TO ELECTRIC SERVICE

Xcel Energy has again CANCELLED their maintenance work on the transmission lines that serve the City of Arlington's electrical substations for Wednesday, April 30th due to recent weather events.

The new scheduled date for Xcel's maintenance work is set for Wednesday, May 14th. Between the hours of 6:00-6:30 AM and again between 4:00-4:30 PM, two (2) ten minute outages will occur as line crews transfer electrical service from one substation to another. This will allow Xcel Energy crews to conduct their maintenance work throughout the day. In case of inclement weather, the maintenance will be rescheduled for Thurs, May 15.
